William C. "Bill" Reppart Jr. age 64, passed away Sunday, July 23, 2017 and will be missed by many.

Bill was born Oct. 31, 1952 in Topeka, Kansas to William C. Reppart Sr. and Rosalie Ladner-Reppart whom he is preceded in death by.

Bill graduated from Ulysses High School then went on to further his education at the Washburn University in Topeka where he received a bachelor's degree in accounting in 1974.

He then returned in 1989 to Washburn University School of Business where he received his master's in business administration with highest academic achievement and his Juris Doctorate degree with honors in 1993.

After completion of his law and MBA degrees he joined Topeka Technical College where he served as an adjunct faculty member. He instructed numerous classes in business and law related subjects.

In 1993, he became an associate attorney with a general practice law firm. In 1995, he relocated to Grove to join his wife Lorrie Reppart and children Tiffany and Savannah and established a legal practice with Brandon Johnson.

In June of 2000, he established the law firm Mallow, Jenkins, and Reppart. In the fall of 2006 he joined the established law firm of Davis and Thompson in Jay, where he worked until the time of his passing.

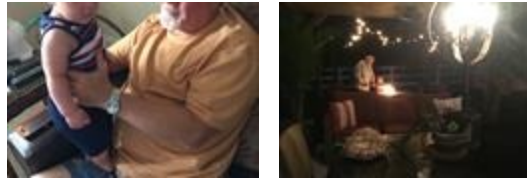

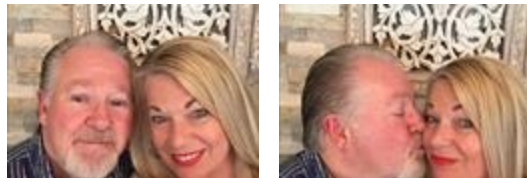
